Who are Animal House Rescue & Grooming and Fort Collins Cat Rescue & Spay/Neuter Clinic?

Our two organizations, soon to merge into Animal Friends Alliance, provide adoption-guarantee sheltering for dogs and cats in need, work to reduce pet overpopulation through our public spay/neuter clinic, and provide many other services to the community, from pet grooming to our Community Cat trap-neuter-return program and our Kibble Supply Pet Food Pantry.

In the past 13 years, we have spayed or neutered 63,000 animals and adopted out 18,000 cats/kittens and 8,000 dogs/puppies. Since we opened our doors, euthanasia rates for Larimer County are down 69% for dogs and cats. Our clinic and shelter are making a difference - please join us!
