All cats taken into the shelter receive thorough medical care including but not limited to: spay/neuter, vaccines, and deworming before going up for adoption. In addition, the shelter provides assistance for feral cats, education for the community and pet food assistance for struggling pet owners.**

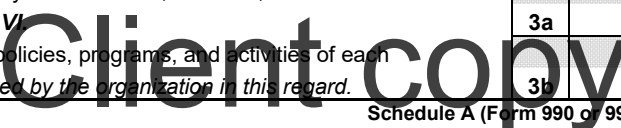

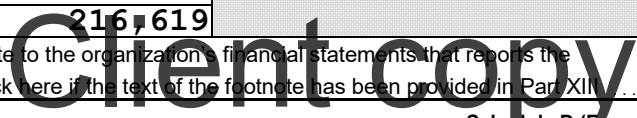
