



Listed below are 3 options a client can qualify for the Kibble Supply program

1. The client can be on any of the government assistance programs listed below.

OR

2. The number of household members and total gross household income (see below) qualifies as low income assistance.

OR

3. Extenuating circumstance(s) such as loss of income/job/medical expenses, which will be up to the Community Pet Resources Manager to determine if the client qualifies.

Government Assistance Programs

Food Stamps Food stamp card or letter from Dept. of Children & Families. A letter with the expiration date

WIC Women, Infants and Children-ID card with expiration date

Medicaid Medicaid card or letter from Dept. of Children & Families with expiration date

Larimer County Works Designed to assist low-income families in moving from monthly cash assistance into the workplace. Letter of acceptance.

TANF Transitional Assistance to Needy Families. Letter of acceptance.

Section 8, Public Housing Letter from Fort Collins Housing Authority or other local housing authority or US Dept. of HUD (Housing and Urban Development) Federal Housing Administration.

LEAP Low Income Energy Assistance Program, letter of approval into the program from the state of Colorado.

Colorado PEAK Online platform where you can apply for or manage medical, SNAP, cash, or other State of Colorado benefits. Copy of card and case number.

OAP Old Age Pension-Provides assistance and health care benefits for low-income adults aged 60 or older. Letter of acceptance.

AND Aid to the Needy Disabled is a cash assistance program for qualifying disabled individuals under age 60. Letter of acceptance.

CCAP Child Care Assistance Program, offers financial assistance to subsidize child care costs through contracted providers, for families who meet low income guidelines. Letter of acceptance, and check expiration date.

OLTC Options for Long Term Care, provides assessment and on-going case management to older and disabled individuals who are in need of long-term care services in their own homes or in alternative care facilities. Letter of acceptance.

Low Income

Income listed is **TOTAL GROSS INCOME FOR HOUSEHOLD**.

**A Household is defined as the total number of related or unrelated persons living at the same address who purchase, prepare and consume food together. Household income is the combined income of said persons.*

Income Guidelines:

These are some types of proof requested by all household members receiving income:

Salary, Wages, Tips, Bonuses, Commissions	W-2s or 1040 form for past year, or pay stub(s) from recent 30 day/4 week period, or signed/dated letter on company letterhead from employer with gross earnings for a specified current period, i.e. monthly.
Social Security (including disability/survivors)	Most recent check stub showing current amount & frequency, or statement/letter from Social Security Authority showing current amount & frequency
Military	Most recent Leave and Earnings Statement (LES)
Unemployment or Workers Comp	Most recent check stub showing current amount & frequency, or signed/dated letter or document from Unemployment Office or insurance company showing current amount and frequency
Veteran Benefits	Signed/dated letter or document from VA showing current amount & frequency
